##### **3.2.1. Introduction**

##### **3.2.2. Reduction of Greenhouse Gas (GHG) emissions – mitigation**

Based on existing official documents (national communications, BURs, NDCs, sectoral policy documents, NAMAs and others, including the results of international and bilateral projects), commitment under the international treaties and Energy Community Treaty as well as consultations with stakeholders two priority programmes to be submitted to the GCF up to 2025 are identified:

###### **1. Increasing energy efficiency in buildings**

Within this programme, project: „**Near Zero-Energy Buildings (NZE) Renovation Project for Public and Cultural Heritage Buildings in Serbia**” is proposed (for achievement of commitment under the Energy Community Treaty).

The project assumes renovation of 28 central government buildings in competence of UZZPRO as per BAU scenario.

Total budget: 58 mil EUR, including 10, 2 miliona EUR from GCF. Partners at the project are Ministry of Mining and Energy and the UNDP.

###### **2. Development of the network for charging electric and hybrid vehicles that use renewable energy sources (RES)**

There are initiatives of the Ministry of transportation, innovation and city of Bgrade. Detailed study on possibilities and need is still lacking.

Cooperation with the GCF shall be realized after development of such Study and specific projects.

##### **3.2.3. Adaptation to climate change**

Based on the First and the Second National communications, NDCs, draft NAP, sectoral policy and legal documents, and consultations with stakeholders', disaster risk reduction, including water related, and improvement of infrastructure relevant for agriculture as well as implementation of other measures are recognized as the priority in adaptation field. Selection of actions shall be based also on their mitigation potential.

The first project recognized under this programme is: "Fruit and vegetable production' vulnerability decrease".

The project assumes development of the complete project documentation for irrigation/drainage systems in 15 local communities and Water master plans for 47 local communities.

Total budget: 104,65 mil USD, including 13 mil USD fro the GCF.
